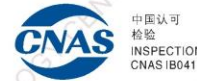

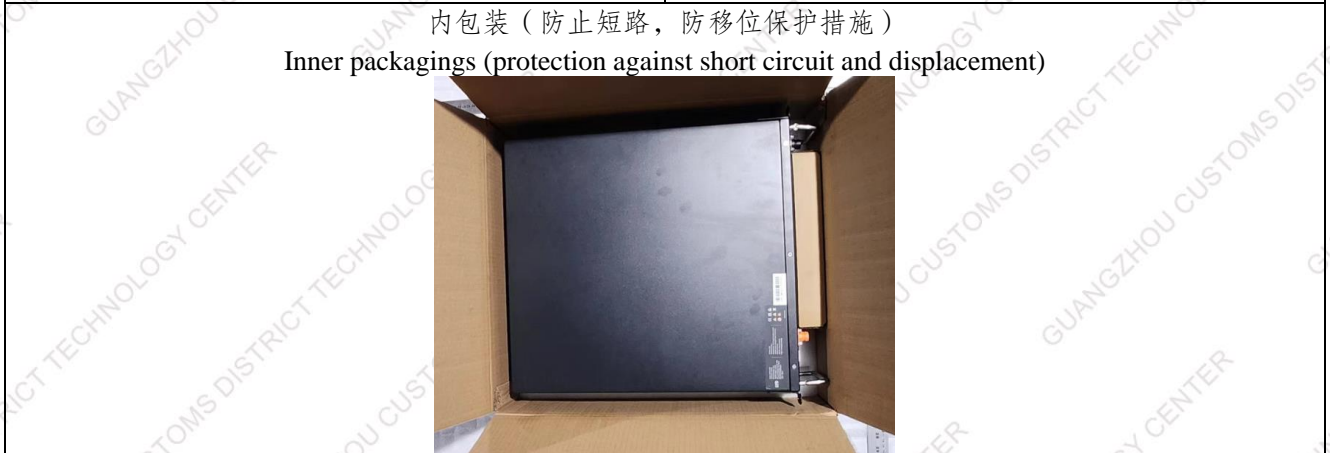

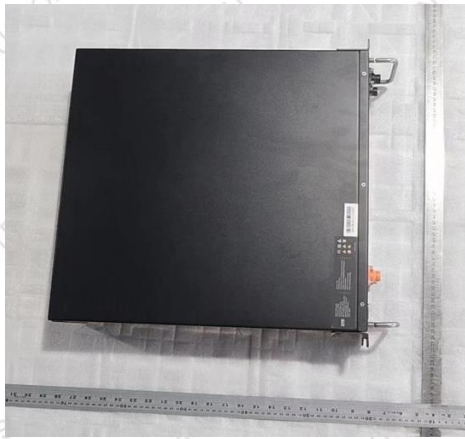

Battery front appearance



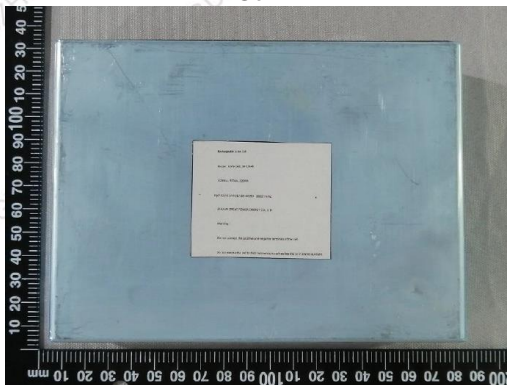
电池侧面外观
Battery side appearance



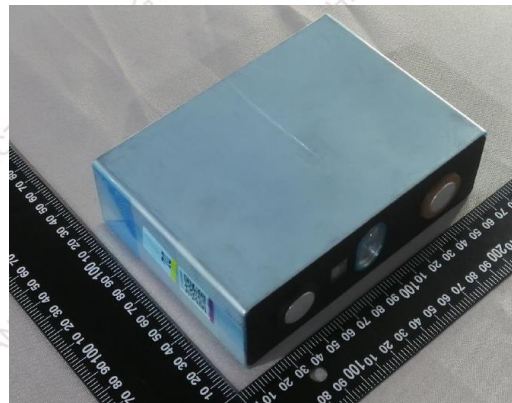

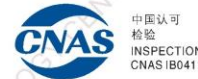
